## Dear Parent/Guardian:

This letter is to provide you with vital information concerning the state's testing program for students at Conway Middle School this school year. There are several tests that students are required to show that they have mastered learning standards for each subject and grade level. The grade level and subject/course determines which test a student will take. Students will be required to take End of Grade assessments (grades 6-8). These tests are aligned to the North Carolina Standard Course of Study and will assess students' knowledge of content taught. Please review the chart below:

<sup>\*</sup>Please have your student at school first thing in the morning on the days they are to test. Once the testing sessions begin a student will not be able to enter the session late. Makeup testing will occur on an as needed basis in the afternoons following regular testing in the morning. Students will not be allowed to have any electronic device on them in the testing session, to include, cell phones, smart watches, earbuds, fitbit, ipads, etc. If students bring those to school they will be collected until after testing is over for the day.

All state assessments must be taken within the time frame given. Please note that students will not be given permission to take assessments before the testing window begins or after it ends. Only in cases of medical emergency will exemptions be given. Students who do not test during the testing window and who are also absent from makeup will not receive a test score, this could result in students failing a course for which a test is required.
