**Parents/guardians who fail to request school bus transportation for their child (ren) in advance of the August 3<sup>rd</sup> deadline, may not have bus transportation provided for their child (ren) for up to 10 days after the first day of school in August.**

If parents/guardians request bus transportation after the August 3<sup>rd</sup> 2020 deadline, they will have to provide transportation for their children to and from school until bus transportation arrangements can be determined - **this might not occur until ten (10) days after the school has started.**

By signing below, I signify that I have read and understand the instructions on this form. I also understand that if this form is not returned to the school by the April 10, 2020 deadline, my child may not be provided bus transportation for up to 10 days after the first day of school in August 2020.
